

## LARAMIE COUNTY PRIMARY ELECTION PROCLAMATION

The Clerk of Laramie County, in accordance with the Secretary of State, and as directed by Federal and State mandates, proclaims that August 18, 2020 is the date of the Primary Election to fill various and prescribed United States, State of Wyoming, District, Laramie County, and City of Cheyenne public offices.

All residents of Laramie County who are 18 years of age or older on or before August 18, 2020 and if not registered, are encouraged to register to vote on or before August 3, 2020, and participate in this election. Acceptable identification is required to register. Residents may register at the polls on Election Day. Absentee voting begins July 2, 2020 and ends August 17, 2020.

Each political party in each precinct shall elect one (1) committeeman and one (1) committeewoman for each two hundred fifty (250) votes, or a major fraction thereof, cast for the party's candidate for representative in congress in the last general election, but provided that no precinct shall be entitled to less than one (1) precinct committeeman and precinct committeewoman. If a precinct boundary line is changed for any reason, the County Commissioners shall determine the number of precinct committeemen and committeewomen to which the affected precinct is entitled. The term of office for all precinct committeemen and committeewoman shall begin on the first Monday in January of the year following their election.
