Good morning board members,

I apologize for using the label "ultra conservative activist" in my communication with Perry.

Using that term should not imply that I don't support their right to freedom of speech and freedom of conscience. Something I live by and regularly emphasize to the FCLS staff is the duty of the library 1) to not have a political agenda and 2) to treat every single person who comes into our libraries with respect.

The point of heightened concern for me as the library director is that someone seeks to be on the board who has demonstrated through their speech or actions to advocate for a viewpoint that I believe is contrary to the library's duty to uphold the Constitutional rights of everyone.

If an applicant demonstrated "ultra progressive activist" speech or actions, I would similarly have a heightened concern about having them on the library board. Again, it is not political affiliation or philosophical ideology which is the basis of my concern. It is what I have observed in someone's speech or actions.

Our current board is an excellent example of people with a variety of viewpoints who work together successfully to guide the library system in upholding the Constitutional rights of all Fremont County citizens as stated in the Wyoming Constitution, Article I, Section 20.

Kristen, thank you for sharing your thoughts and concerns. Perry, I have observed through your actions that you respect each person's right to their perspective and that you take time to listen to other perspectives.

Kristen;

I, as always, really value your opinion. I think there are several issues that are being confused here. We need to separate our personal beliefs, our cultural beliefs, and our job as Board members.

- 1. As Board members we need to come to the Board in support of the Library system, not as purveyors of any specific agenda.
- 2. It is very helpful to have a Board comprising multiple different viewpoints, religions, and political interests (I think we have that in our current group and I would never advocate a homogenous Board)
- 3. A well functioning Board is beneficial to the Library and to the County commissioners who oversee the library system. You and I have gone through a period of a contentious, dysfunctional Board and that was a disaster in terms of funding and organizational health.

My concern with the current applicants is that their history shows them to be activists pushing a specific agenda. I do not think that is an appropriate person to have on any Board. A Board member should be someone who is interested in the whole of the system not just restricting or reformatting one facet. The County Commissioners will decide what kind of Board they want and may or may not renew either my or Sherry's application. At the end are a couple of excerpts from the Wyoming Board members Handbook.

I value community input whether it is contentious or not. At the last meeting it was really helpful having input as we don't know what the Library's legal responsibility is regarding policing of private functions in the leased meeting rooms. Very interesting question and I am eager to see the legal opinion.

I did decide to put my name up because this last year had been very productive and we do still need to work on policies and procedures (your area of expertise), more funding etc. I think we owe it to the Director and the County to continue on our path of calm, rational, non-confronting, fiscally responsible decision making. Plus you guys are freaking awesome to work with

"Intellectual Freedom: As public officials, Board Members have an obligation to uphold the Constitutional right of free speech. Board Members have a responsibility to resist censorship of library materials by groups or individuals, regardless of personal feelings and beliefs."

"Intellectual Freedom

It's been said that a good library has something to offend everyone, and yours is likely no exception. Public libraries serve an important role in democracy by providing materials that reflect all viewpoints. Intellectual freedom is a major concern of libraries. Individuals or groups may attempt to censor library materials that they feel are objectionable. The Library Board has the responsibility of championing the cause of intellectual freedom, including fighting all censorship efforts. This can be a difficult and uncomfortable responsibility, but it is necessary for the proper functioning of libraries.

The selection of library materials is an essential process that is strongly related to intellectual freedom. The Board must adopt a written materials selection policy for the library, which reflects the library's mission and goals. It should also clearly support the right of all members of the community to have access to a wide range of materials, including items that some people might find to be objectionable.

In some cases, persons objecting to library materials may attempt to persuade the library to remove those items. To address these attempts, the Library Board should adopt a policy and procedure for the filing of and the hearing of complaints. A good practice is to have a Reconsideration Form for patrons who want to challenge a book.

A great deal of information now comes through electronic means. Your library should adopt an Internet use policy that respects the rights of your patrons to freely access information."
