SUBJECT Government Expenditures on Association Dues

Question: What is the total amount of Wyoming tax dollars paid to professional associations for dues?

Short Answer: This question is answered in three sections:

A. Local governments paid approximately \$515,825 in membership dues for fiscal year (FY) 2024 to Wyoming county government associations, not including dues to the Wyoming Association of Municipalities.

B. LSO staff estimate state agencies expended approximately \$3.2 million on association dues in the 2023-2024 biennium.

C. For the 2025-2026 biennium, the Legislature approved \$138,400 in exception requests specifically for increases for professional association dues.

A. Association Dues Paid by Local Governments for FY 2024. (Annual amounts.)

There are eight (8) primary local government associations to which local governments in Wyoming pay dues. LSO requested from each association information on the dues paid for FY 2024. The results are summarized in Table 1. The total for these association dues for FY 2024 was \$515,825.

* The dues each county pays to the Wyoming County Commissioners Association (WCCA) vary because dues are based on a formula consisting of population, assessed value, sales and use tax revenue, payment in lieu of taxes, and direct distribution.

** The Wyoming Association of Municipalities (WAM), as a private nonprofit organization, would not share dues information with LSO but did share there are 98 members.

B. Association Dues Paid by State Agencies for the 2023-2024 Biennium.

Based on data from the State's accounting system, known as WOLFS, LSO staff estimate state agencies expended approximately \$3.2 million from funds sourced with Wyoming taxes for association dues during the 2023-2024 fiscal biennium. This analysis is based on actual expenditures rather than appropriated amounts. Attachment A summarizes the identified expenditures by agency, division, and vendor for the 2023-2024 biennium. It further identifies the fund source of the expenditure. Because LSO staff derived this information from accounting data, discussions with state agencies may be necessary to develop a full understanding of expenditures listed in Attachment A.

Methodology. LSO staff derived the estimate of \$3.2 million by extracting data from WOLF transactions coded "Dues and Membership Fees 0207.01". The State Auditor's Office provides the following definition of expenditures in this category:

Dues and Membership Fees 0207.01: Individual or agency participation in associations, organizations, or conventions that benefit the state or the agency including the cost of subscriptions that accompany these memberships, current professional licensing fees for employees that is necessary or required to perform their current job or enable the employee to remain current in the job-related field such as driver license fees, CDL, notary commissions, certifications, accreditation, etc.

LSO staff inherently rely on accurate population of the accounting data in this expenditure code. LSO staff then refined the data to hone in on the requested information. For example, LSO developed a representation of the vendor name or aggregated vendor names as needed. The vendor names are often truncated or acronyms, and the full name of the association often was not readily available without researching supporting documentation for each individual transaction.

Because the "Dues and Membership Fees 0207.01" accounting code is broader than the information requested, i.e., association dues, LSO staff attempted to remove nonqualifying categories of expenditures. For example, LSO staff removed identifiable expenditures for professional licensing, such as the Wyoming Bar Association. However, doing so involved judgement, and the results are fallible. Finally, LSO staff limited the expenditures to only those occurring from tax revenue rather than funds such as occupational licensing fees and other non-tax, yet public revenue. Discussion with agencies would be needed to verify whether necessary professional licensing fees are included. Further, it appears that some association memberships may include professional licensing or continuing education.

LSO staff sought to eliminate other expenditures outside the scope of interest, such as expenditures for webinar or conference registrations. LSO eliminated memberships or subscriptions for Sam's Club, subscriptions to software providers and other businesses or services unrelated to substantive membership associations.

When identified, LSO also removed transactions that appeared to be coded erroneously.

C. Exception Requests in 2025-2026 Biennial Budget.

LSO researched exception requests in the recently legislated budget for the 2024-2025 biennium to provide an indication of increases that may occur in the current biennium. (*Staff note: Budget requests are aggregated at object code 0207; funds are not requested at the sub object code level, 0207.01.*) For the 2025-2026 biennium, the Legislature approved the following exception requests specifically related to professional association dues totaling \$138,400. Specifically, the Legislature approved:

- An exception request for the Governor's Office for an ongoing \$106,200 General Funds (GF) for dues to the Education Commission of the States. Additionally, the standard budget contains \$120,000 GF in the standard budget used to pay for dues to the National Governors Association and the Western Governors Association and \$94,903 GF used to pay for annual dues, registration fees, and travel expenses to attend the annual conferences associated with the Commission on Uniform Laws;
- An exception request of the State Construction Department to increase object code 0207 in The Infrastructure Division by \$11,400 GF;
- An exception request of the State Budget Department for \$20,800 GF for dues to the National Association of State Budget Officers.
